Dear Guild Members and potential Guild Members:

Bravo/Brava!! It is time to renew your membership with the Anchorage Opera Guild for the 2007/2008 year. We look forward to your joining us.

In addition to making a substantial donation to the Anchorage Opera Company, the Guild provides scholarships and education about opera, volunteer opportunities and occasions for socializing with people who have a similar interest – opera.

There are three tax-deductible membership levels in the Anchorage Opera Guild:

1. Light Opera is \$30.00 for a single and \$50.00 for a pair.
2. Operetta level is \$60.00 for a single and \$100.00 a pair.
3. Grand Opera level is \$150.00 for a single and \$250.00 a pair.

Members at all levels have the opportunity to pre-order sets of tickets for the three “Star” events at \$100.00 per set of three for themselves and their friends. This is a \$150.00 value for only \$100.00 a savings of \$50.00. The Star events are two “Lunch[es] with the Stars” and one “Afternoon with the Stars.” Ticket sets are not tax-deductible.

Any additional donations will, of course, be gratefully accepted. Kisses from your AOG Board for all the support you can contribute.

Opera Guild meetings/parties also include, at a minimal cost, a December Holiday party, and a May Membership party, and one or more annual fundraisers. We encourage all members to participate in planning and/or attending these events. Local artists provide musical entertainment.

Other than mailing costs, etc. we have no office or salary expenses. The Guild operates with volunteers only. All the funds we receive, including proceeds from fundraisers, are donated to the Anchorage Opera Company or to a music scholarship fund. Please consider an additional donation with your membership.
